MAHARAJA SCHOLARSHIPS SCHEME FOR UNIVERSITY ENTRANTS FOR THE ACADEMIC YEAR 2018/2019

The University Grants Commission invites applications for the above scholarships scheme from the applicants who have excelled in Extra Curricular Activities.

1. Value of the scholarship will be Rs.25, 000/- per recipient for the academic year.
2. Two Scholarships per academic year will be awarded to a deserving student on the result of G.C.E. (A/L) examination in 2018.
3. Eligibility Criteria
 - I. Students who are in the Academic Year 2018/2019, based on the results of 2018 GCE A/L Examinations and who are registered and follow a degree programme at a University under the purview of the UGC.
 - II. Annual Parental income.
(A letter from the employer certifying the salary particulars of the applicant's parents or in the case of unemployed parent a letter or a certificate obtained from the Divisional Secretary on the recommendation of Grama Seva Niladhari of the area of the candidate's permanent residence and income should be submitted.)
 - III. Performance at GCE A/L Examination. (The applicant should have three 'A' grade passes in his/her initial attempt at the G.C.E. (A/L) examination)
 - IV. The applicant must satisfy the selection Committee with his/her contribution to the extra-curricular activities at national/international level.
 - V. Students who are not receiving any financial assistance from university or any other organization by way of Mahapola, Bursary or any other scholarship.
4. The decision of the selection panel will be the final and no further correspondence will be entertained.
5. Specimen Application is available at the Dean's office of the relevant Faculty, Student Welfare Branch of the University and UGC website (www.ugc.ac.lk).
6. Closing date of the applications is **20th October 2020**.

- You should attach an income Assessment Report issued by the Divisional Secretariat of your area to prove the income from estates, fields, lands etc. and income from houses rented or leased.
- Salary particulars including all allowances regarding the Gross Annual Income of your father/ mother from the occupation pension certified by the respective employer (Original) should be attached. If your father/ mother is an entrepreneur/ self-employed, an Income Assessment Report certified by the Divisional Secretariat should be attached. (Period of 12 months from January 2019 to December 2019).
- If your father's /mother's service has been terminated or he/ she has retired during the income assessment period (i.e. from January 2019 to December 2019) you should clearly state such period and attach certified copies of documents (pension award letter or employment termination letter) issued by the relevant authorities.
- Particulars regarding sources of income and all other information should be stated in full. Particulars of income furnished by you, will be checked with relevant Grama Niladhari officers and the Divisional Secretariat.
- If you have any school going brothers or sisters who are 19 years or below, you should attached the certified copies of the birth certificate of them.
- Part A, B & C should be dully filled by the applicant and handed over to the Registrar of the particular University in order to complete Part D.
- Incomplete applications will be rejected and copy of the **National Identity card should be attached.**
- The closing date of applications is **20th October 2020.**
